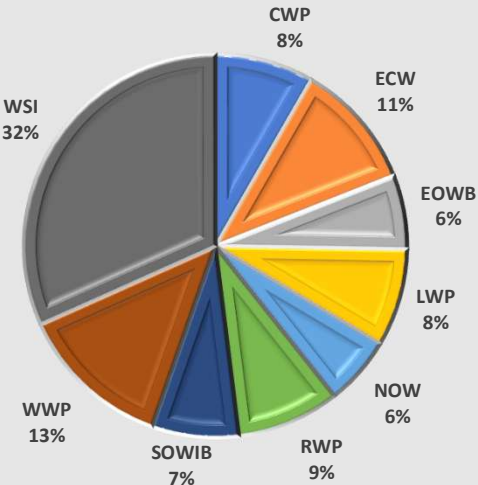

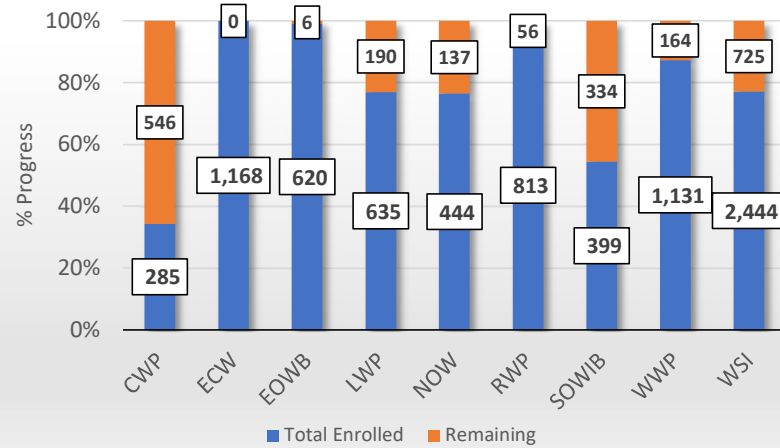

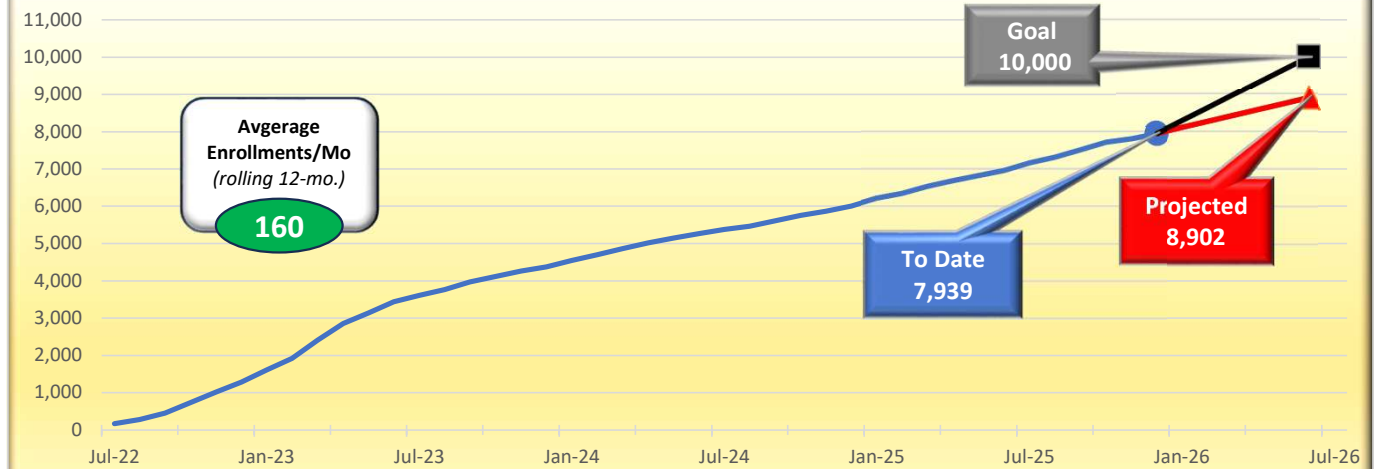

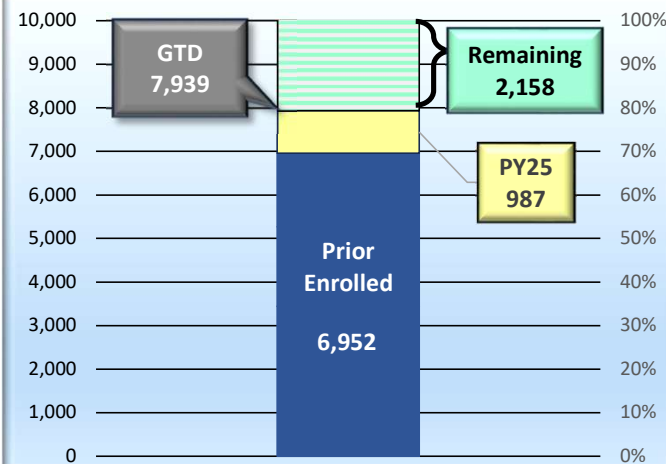
Progress to Enrollment Goals



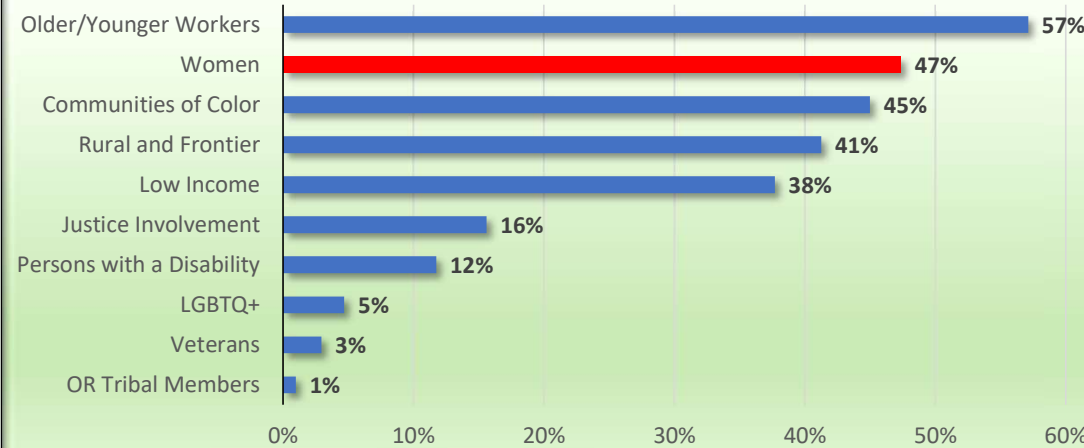

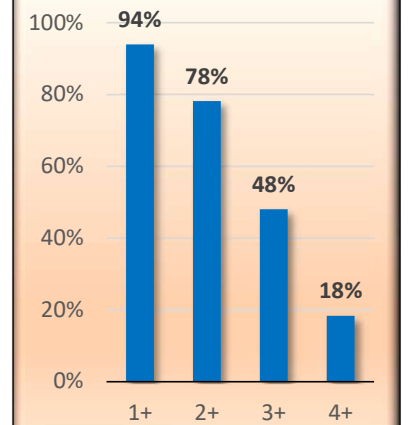

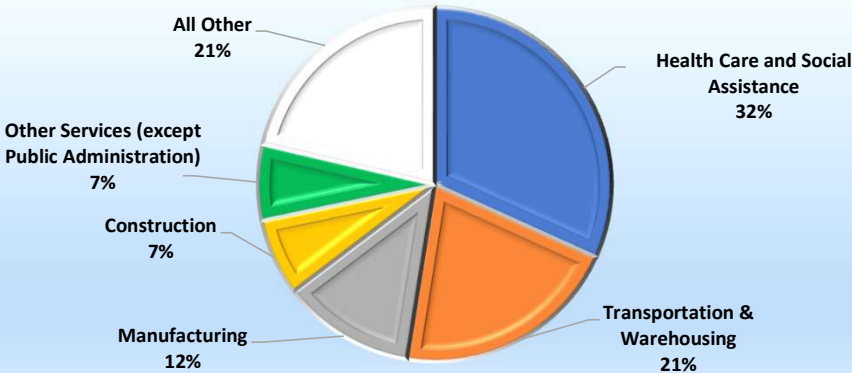

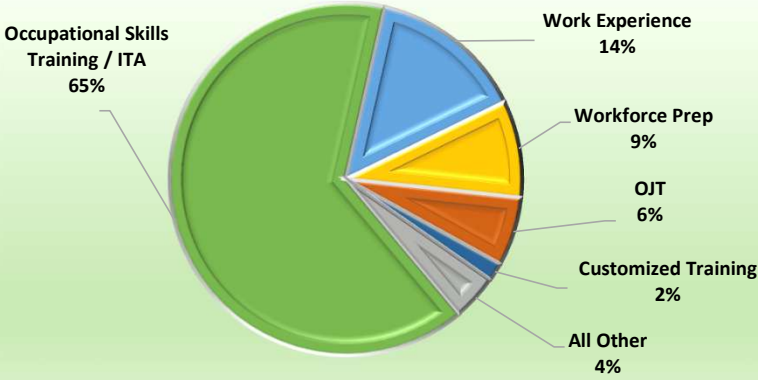

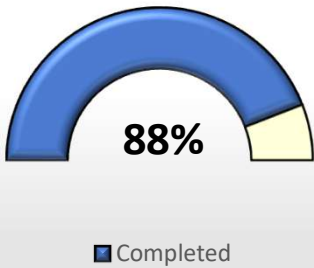
Top 5: Training By Industry Focus



Top 5: Supported Training Types

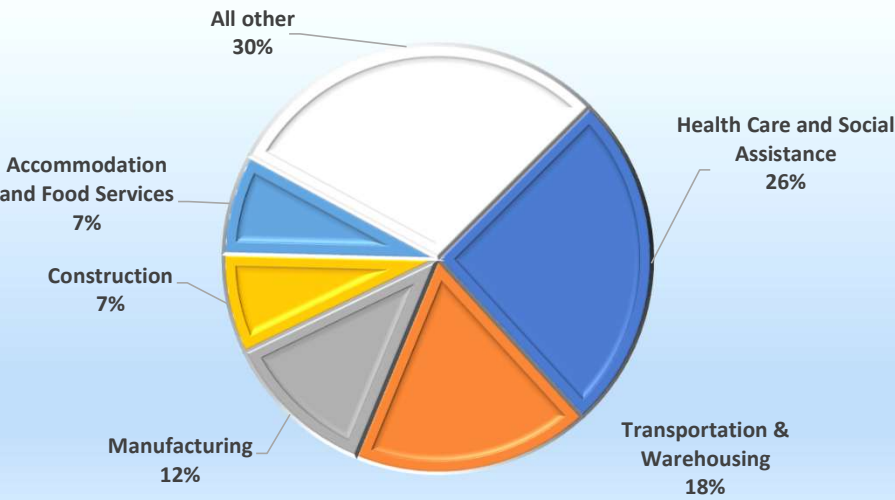


Training Completion Rate

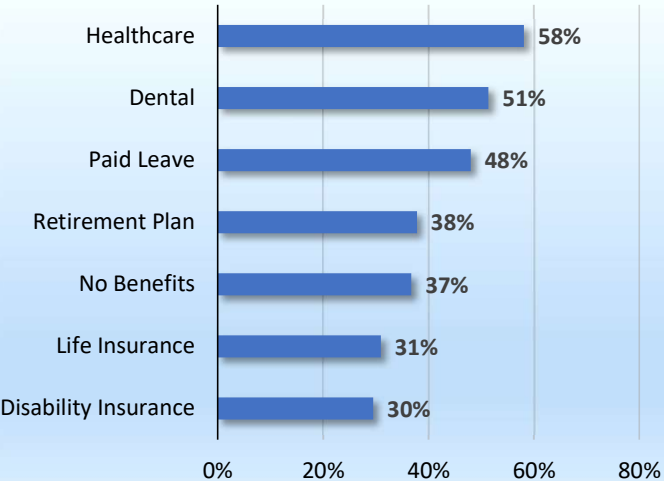

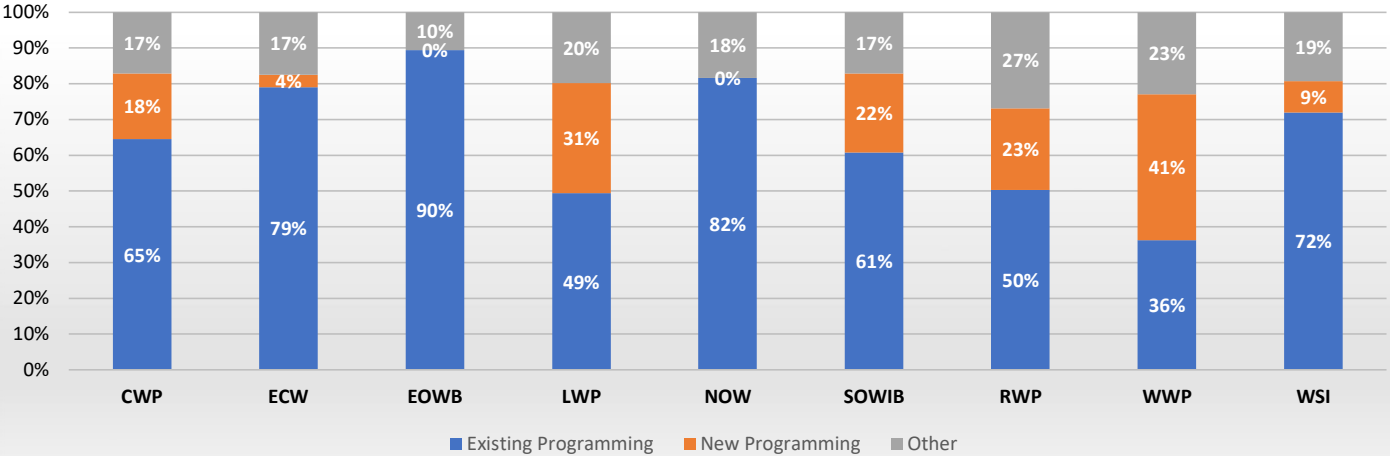
